CALL TO ORDER

Chairman Mario Dipola called the meeting to order at 2 p.m. and David Duckworth led the Pledge of Allegiance.

PUBLIC COMMENT

None.

▶ A. APPROVE THE MAY 1, 2024 MEETING MINUTES

Chairman Mario Dipola asked for approval of the minutes of the May Citizens Advisory Committee meeting.

Charles Pappas moved to approve the May 1, 2024 minutes; Joanne Kazmierski seconded; motion unanimously carried.

▶ B. APPROVAL OF THE TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR FY 2024/25 THROUGH FY 2028/29

Elizabeth De Jesus informed the group the draft TIP was presented along with a presentation demonstrating the new TIP interactive tool at last month's meeting. The first draft was posted on the TPO website April 25, with the complete draft being posted May 3. PowerPoint virtual presentations were given for Clay, Duval, Nassau and St. Johns Counties during the month of May. In addition, a regional TIP virtual public meeting was held May 23. Public involvement efforts included promoting the virtual presentations through the TPO's e-newsletter, local newspaper advertising and social media.

Jeff Sheffield informed the group in an effort to address questions submitted by Jim Green in a timely manner, staff will provide those responses here today. **(See Attachment A)**

Ms. De Jesus asked for questions.

- Jim Green commented the two projects where they identify US 90 alternate as going to the beach, in his opinion, is incorrect. US 90 alternate goes across the Matthews Bridge/Arlington Expressway down Southside Blvd. where it rejoins US 90 at Beach Blvd. FDOT is indicating US 90 alternate goes out Atlantic Blvd. to A-1-A at the Beaches.

- Jim Green commented FDOT did not understand the question of the relocated fairgrounds. Mr. Green was not asking if a road would be built for the fairgrounds. The question was can the resurfacing project accommodate a new entrance to the fairgrounds.
- Jim Green commented FDOT is not consistent with the naming of projects.
- Chairman Dipola commented it is not consistent and makes sorting difficult.
- Mr. Sheffield responded TPO staff would manually reconcile the project names. With the new TIP interactive tool, we now do a direct upload from FDOT. If we were to change the names and there is a change within the project, we would not be able to reconcile it.
- Elizabeth De Jesus commented the tool has an interactive map that allows you to zoom in on a particular area and see all the projects within that area.
- Lisa McGlynn commented the current road naming is very difficult to understand.
- Charles Pappas suggested the feedback go to the company that developed the new software tool.

Mr. Sheffield responded we purchased the software directly from the company, and it consumes data directly from the FDOT mainframe.

- Nichole Mobley wanted to know if the TPO could tell the software company what they want in the program to get the desired results.

Mr. Sheffield responded if we took SR 10 and input it in as Atlantic Blvd. it will no longer match and will not be able to be reconciled. Most citizens will probably use the map feature to look at projects within their area.

- Joanne Kazmierski thanked Jim Green for his attention to detail and effort he put into reviewing the TIP and submitting questions/comments.
- Elizabeth De Jesus thanked everyone who submitted comments, which will be reflected in the final TIP.
- Elizabeth De Jesus recognized Bernie O'Connor as the first person to submit comments through the new TIP tool.

Jim Green moved to approve the Transportation Improvement Program (TIP) for FY 2024/25 through FY 2028/29; Bernie O'Connor seconded; motion unanimously carried.

► C. **FDOT REQUESTS AMENDING THE FY 2023/24 THROUGH FY 2027/28 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

Hillary Laskey presented the following amendment to the Transportation Improvement Program (TIP) for FY 2023/24 through FY 2027/28.

Ms. Laskey asked for questions. There are no questions at this time.

Bernie O'Connor moved to approve the FDOT's request to amend the FY 2023/24 through FY 2027/28 Transportation Improvement Program (TIP); Barney Roberts seconded; motion unanimously carried.

► D. **JTA REQUESTS AMENDING THE FY 2023/24 THROUGH FY 2027/28 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

Jeremy Norsworthy presented the following amendment to the Transportation Improvement Program (TIP) for FY 2023/24 through FY 2027/28. This project is for the remaining five segments of the Emerald Trail.

A copy of the request is included in Section D, which includes the following project:

- 2023 Reconnecting Communities and Neighborhoods (RCN) Grant Program

Mr. Norsworthy asked for questions. There are no questions at this time.

Barney Roberts moved to approve the JTA's request to amend the FY 2023/24 through FY 2027/28 Transportation Improvement Program (TIP); Bernie O'Connor seconded; motion unanimously carried.

► E. **REVISED CAC BYLAWS**

Jeff Sheffield presented the proposed changes to the CAC bylaws.

- Remove "At-large" designated positions as it relates to CPACs.

- Propose changing the number of absences from four to three before declaring a seat vacant.
- A formal rotation for Chair and Vice Chair by county.
- Removal of language for meeting notice through newspaper to reflect the legal requirement. This aligns with the Public Participation Plan.

Mr. Sheffield asked for questions.

- Lisa McGlynn commented we are all volunteers and are not paid to attend the meetings. Ms. McGlynn thinks it is important to track attendance. She likes the idea of the flexibility of three meetings in a calendar year vs. missing three consecutive meetings.
- Jeff Sheffield commented the flexibility of missing three meetings in a calendar year triggers us to reach out to you quicker to determine if you want to continue on the committee.
- Barney Roberts commented we need to keep this flexible.
- Doug Conkey wanted to know if it is three excused absences or absent.

Mr. Sheffield responded there are no excused absences.

- Jim Hill wanted to know how the two-term limit works for the officer positions given the proposed rotation schedule.

Mr. Sheffield responded it will be reconciled with the rotation schedule and will be a one-term limit.

- Charles Pappas commented that with the elimination of Section 2 the remaining items need to be renumbered.
- Jim Green commented there are several instances of he/she or s/he within the document. Mr. Green suggested they be replaced with "they".

Ms. Larson responded if you are unsure of the gender it is traditional to use he/she or s/he. There are instances where "they" will not work. Ms. Larson suggested leaving it as is.

Mr. Sheffield commented we are pretty comfortable with the way it is at the moment.

- Jim Green commented using the pronouns he/she and s/he are not consistent throughout the document.

Mr. Sheffield responded we will make sure it is consistent.

- Joanne Kazmierski wanted to know if there is an open nomination process for the officer positions.

Mr. Sheffield responded that every December we have nominations for the officer positions during the meeting. There is no nominating committee.

- John Stack wanted to know why the “At-large” was dropped.

Mr. Sheffield responded Duval County had designated CPAC members and other At-large members. We no longer reference specific CPACs. We removed this for consistency.

Barney Roberts moved to approve the revised bylaws with the proposed changes; Charles Pappas seconded; motion unanimously carried.

F. LONG RANGE TRANSPORTATION PLAN (LRTP) UPDATE

Wiley Page gave a brief update on the LRTP.

Mr. Page asked for questions.

- Mario Dipola wanted to know if the Work Program has been stripped of local projects and funds reallocated to provide funding to local agencies for projects.

Mr. Sheffield responded he is not aware of anything related to local projects.

G. SMART NORTH FLORIDA UPDATE

Clayton Levins gave the following update.

- GeoMate – satellite images for roadway inventory
Pilot project in the Arlington area with 90% accuracy.
- CYVL AI – lidar for roadway inventory
Pilot project with ETM in Neptune Beach.
- Mario Dipola asked how this compares to Clay County's pilot with Robotics. Mr. Dipola asked if they have any intent to use one of these solutions again or is it a one and done.

Mr. Levins responded some of the counties that did these types of assessments only occur once every few years. Mr. Levins suggested that Chairman Dipola check out Nassau County's 20-year road management plan.

Mr. Sheffield commented Nassau County is releasing an RFP for this type of work and will craft it to allow Suwannee and Perry to piggyback on the contract.

- Doug Conkey asked, for contracting purposes, do these products require a state license or certification.

Mr. Sheffield responded you want to be on the Approved Product List (APL) for the state and/or the Innovation Product List (IPL).

H. OLD BUSINESS

- May 9, 2024 North Florida TPO Meeting Report

MAY 1, 2024 CAC Meeting – Response Needed from Staff/FDOT

- Bernie O'Connor asked for a description of the First Coast Flyer Green Line.

JTA Response - The JTA's premium bus rapid transit (BRT) service is known as the First Coast Flyer consists of four routes. The FCF offers customers a more direct and more frequent service compared to regular fixed-route bus service. The Flyer follows some of Jacksonville's busiest mobility corridors, from the east, southeast, west, and north to create a 57-mile network connected to the Jacksonville Regional Transportation Center at LaVilla (JRTC).

The FCF Green Line launched in December 2015. As presently constructed, the FCF Green line is a 10-mile BRT line that provides service from the JRTC LaVilla along Lem Turner Boulevard to I-295. The Green Line features 18 branded FCF stations, CNG- powered buses, a Park-n-Ride facility located on Armsdale Road, and transit signal priority. I. NEW BUSINESS

Marci Larson informed the group we have new signage on the corner of the building and new decals on the front window and doors.

J. CAC COMMENT

- Doug Conkey commented \$1.3 billion is available for EV chargers. Mr. Conkey wanted to know if our area will receive any of this funding.

Mr. Sheffield responded the problem is the ability to spend the money and deploy it.

Ms. Larson responded it is a grant that was released by the government. We would have to apply for the funding.

- Doug Conkey commented California is pushing Vehicle Miles Traveled (VMT).

- Charles Pappas commented the gas tax has been declining for many reasons. Citizens purchased more fuel efficient vehicles and drove less.
- Chairman Dipola commented former FDOT Secretary Prasad's solution was to toll all new capacity projects to generate funding. He was very unpopular for that suggestion.
- Jim Green commented several of the large insurance companies offer many programs to lower your insurance rates. For example, driving an electric vehicle.

Mr. Sheffield responded the public can't reconcile the idea of paying to drive a vehicle.
