Ms. Martinage asked for questions.

- LeAnna Cumber commented that the Bay Street Innovation Corridor falls under Florida New Starts funding. Ms. Cumber wanted to know since the U2C does not have any dedicated lanes how does it qualify as a fixed guideway; thereby, qualifying for New Starts funding.

Ms. Martinage deferred to JTA to answer this question.

Jim Knight responded that he would have to check with Ms. Joyner-Howard of FDOT's transit department and get back to Ms. Cumber with a response.

- LeAnna Cumber commented that the budget submitted and approved by the City Council for the U2C is \$29.1 million that includes an FTA match of \$12.5 million, a COJ contribution of \$8.3 million and a state match of \$8.3 million. Ms. Cumber wanted to know where the \$13 million is coming from. Under state law, the state can only contribute 50 percent of the non-federal match. There is an extra \$5 million in the budget that was not approved by the City Council.

Jim Knight responded that the last budget he saw was \$44 million. Mr. Knight will get with Ms. Joyner-Howard and get back to Ms. Cumber with a response.

- LeAnna Cumber requested that project 444078-2 - U2C Bay Street Innovation Corridor be deferred until next month.
- Randy DeFoor requested that staff provide the responses to these questions to all the Board members.
- Greer Gillis commented that JTA goes through the New Starts process for new train service. The U2C is not on a fixed guideway, but it will be running in mixed traffic. JTA has \$44 million allocated for the first phase of this project with matching federal, state and city funds that include BUILD grant funds.

**LeAnna Cumber moved to defer the 444078-2 – U2C Bay Street Innovation Corridor project; Randy DeFoor seconded; motion unanimously carried.**

**Wayne Bolla moved to approve the FDOT’s request to amend the Transportation Improvement Program (TIP) for FY 2020/21 through FY 2024/25; LeAnna Cumber seconded; motion unanimously carried.**

**C. DRAFT FY 2021/22 UNIFIED PLANNING WORK PROGRAM (UPWP)**

Denise Bunnewith presented the complete draft of the FY 2021/22 Unified Planning Work Program (UPWP). Approval will be requested at the May meeting. The following projects were added to Section 5, Special Projects.

Ms. Bunnewith asked for questions. There were no questions at this time.

**D. DRAFT PROJECT SECTIONS FOR THE FY 2021/22 THROUGH FY 2025/26 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

Wanda Forrest presented the draft project sections for the FY 2021/22 through FY 2025/26 Transportation Improvement Program (TIP). The complete draft will be presented next month, with approval requested in June.

Ms. Forrest asked for questions.

- Jeff Sheffield informed the Board that Wanda Forrest is retiring June 30 and Elizabeth DeJesus will assume the TIP responsibilities.

**E. JAXPORT INITIATIVES PRESENTATION**

James Bennett, Sr. Director of Engineering and Construction, gave an update on JAXPORT's ongoing and upcoming initiatives.

Mr. Bennett asked for questions.

- Randy DeFoor commented that Carnival Cruise Line is threatening to move their home ports outside the U.S. due to the CDC guidelines. Ms. DeFoor would like to know if Mr. Bennett has any information or insight on this.

Mr. Bennett responded that there are other ports outside the U.S. that are not following the CDC guidelines and believes some of this is posturing. As everyone becomes vaccinated, things are opening back up. Carnival Cruise line has announced that they are repositioning some of their smaller vessels and not returning to certain ports. To date, JAXPORT has not heard anything from Carnival Cruise line about not returning to our port.

- Randy DeFoor wanted to know if the ship that is aground a mile south of the St. Johns River entrance is fully laden. Ms. DeFoor wanted to know why ships cannot come in like that.

Mr. Bennett responded that ships cannot come in fully laden because the channel is not deep enough. Our typical vessel is 8 – 10,000 TDUs and we are preparing for 12,000 TDUs. JAXPORT is on the rotation to receive the larger cargo ships once we have the 47 foot deep channel.

- Ray Alfred wanted to know who is liable for the cargo and the ship that were stuck near the entrance to the St. Johns River. Mr. Alfred also wanted to know who is responsible for the employees of these companies.

Mr. Bennett responded that is a private vessel that was destined for a private terminal and is being handled by the U.S. Coast Guard. The tenants and the union are liable for the employees.

- Wayne Bolla wanted to know if JAXPORT has seen any impacts from the canal being shut down.

Mr. Bennett responded that some of the ships have been delayed by a few days. There has not been an impact to our revenues.

- Ray Alfred wanted to know if the port deepening and the entry to the Atlantic Ocean is complete.

Mr. Bennett responded that we have completed eight of the 11 miles of the harbor deepening. The last three miles will be complete in 2022. This will put us all the way through Blount Island and creates another turning basin.

- Thomas Ford wanted to know if the harbor could be deepened beyond 47 feet.

Mr. Bennett responded that JAXPORT could deepen it beyond 47 feet. When the federal government did the study, they determined that the federal depth was 45 feet. JAXPORT would have to show a benefit to go deeper.

- Thomas Ford wanted to know if the depth went from 47 to 50 feet if that would create more opportunity.

Mr. Bennett responded that it does provide more opportunity. It means bigger and heavier ships could come in.

- Christian Whitehurst wanted to know the projected economic impact going from 40 to 47 feet.

Mr. Bennett responded that he does not have that information.

- Elaine Brown wanted to know if JAXPORT has contracts lined up for the megaships that will be coming in.

Mr. Bennett responded that we typically contract with our tenants and they contract with the shipping lines to bring in their products. Our objective is for them to understand JAXPORT's capabilities and our enhanced harbor conditions.

- Ray Alfred wanted to know if there is a corresponding concern for deepening the docks.

Mr. Bennett responded that we are reconstructing the berths for a 50 foot depth.

#### **F. SMART NORTH FLORIDA UPDATE**

Mr. Sheffield gave the following update.

- SNF has hired Clayton Levins as the Executive Director. He will introduce himself to the Board next month.

#### **G. EXECUTIVE DIRECTOR'S REPORT**

- Jeff Sheffield informed the Board that the goal over the next few months is to give each of the five independent authorities the opportunity to present on their ongoing and upcoming initiatives.
- The General Planning Consultant and Marketing Consultant RFPs are out for bid. The goal is to have these two items before you in June for approval, with the contracts executed no later than June 30.

#### **H. SECRETARY OF TRANSPORTATION'S REPORT**

Larry Parks informed the Board that FDOT has projects that are ready when federal stimulus funding becomes available.

#### **I. AUTHORITY REPORTS**

**Ray Alfred – Jacksonville Aviation Authority** – At the end of April, flights from Jacksonville to Los Angeles will increase from two to four flights.

**Daniel Bean – JAXPORT** – We are hoping to receive federal stimulus funding to offset some losses incurred due to COVID-19. We recently signed a Memorandum of Understanding (MOU) with Volusia County to assist and increase the volume of traffic from central Florida to JAXPORT.

**Mike Cole – Nassau County Ocean Highway and Port Authority** – Tonnage is up. New cranes will be arriving shortly. Things are running smoothly at the port.

**Ari Jolly – Jacksonville Transportation Authority** – The JTA has partnered with Agape Family Health to develop the Wellness on Wheels Initiative, which offers mobile vaccinations for the Jacksonville community. Two buses have been retrofitted to become mobile vaccination units and will travel to underserved areas, churches, and long-term living facilities in Jacksonville to help seniors get

access to vaccines. The Florida Division of Emergency Management is dedicating vaccine supplies to this program. Agape Health is providing staff to administer the vaccines and run the program.

JTA officially launched the Clay Community Transportation Green Line April 1, which expands access for residents in Clay County to the Middleburg VA Clinic. The Green Line is the fourth route introduced through Clay Community Transportation, a partnership between the JTA and Clay County. The service runs Monday through Friday with stops in Keystone Heights and Penny Farms on its way to the Middleburg VA Clinic. The Green Line also connects to the Magenta Line, which connects Keystone Heights and Gainesville through two round-trips each weekday.

The refurbished St. Johns River Ferry returned to service April 2 after passing its U.S. Coast Guard inspection and sea trials during the haul out, which is required by the U.S. Coast Guard every 2-3 years to ensure a state of good repair. As a bonus to commuters inconvenienced during the two months it was out of service, the JTA has waived the fare for all crossings through Friday, April 9. In January, JTA began upgrades to the Jean Ribault ferry and the facilities, including pavement rehabilitation and markings, various Americans with Disabilities Act improvements, new bulkheads and mooring bollards, catwalk access improvements, accessory and utility building improvements, construction of new public restroom facilities at the Mayport landing, along with landscaping and lighting enhancements on each side of the ferry.

The Crazy Beans Coffee café opened April 6 inside the JRTC at LaVilla. This breakfast and lunch café offers assorted breakfast sandwiches, salads, and grab-and-go items along with ethically sourced coffee, specialty drinks, and homemade dessert options. Open Monday through Friday, 5 a.m. to 7 p.m. and Saturdays 6 a.m. to 2 p.m., you can find Crazy Beans Coffee near the customer waiting area of the JRTC at LaVilla.

The JTA officially launched a partnership April 7 with Token Transit – a new way for customers to turn cash into digital fares. The new partnership allows anyone to send digital JTA bus fares through text messages, so they can use cashless and touchless digital boarding. Customers can go online to the Token Transit website, use the MyJTA app, or come to the Customer Ticket Center at the JRTC at LaVilla to convert their cash to digital fares.

**Reba Ludlow – St. Augustine – St. Johns County Airport Authority** – We continue to look into commercial service. Construction is ongoing on runway “D”.

**Matt Schellhorn – U.S. Navy Representative** – Installations are still in heightened health conditions for COVID. Shots are being administered at both bases with some changes to the restrictions anticipated later this spring.

Navy Region Southeast Change of Command – April 29, Wes McCall (former CO of Mayport) will relieve RDML Gary Mayes.

NAS JAX – Captain Hill will replace Captain Weiss April 9.

As a reminder, there will not be a Blue Angels air show this year.

During the April board meeting two questions were posed about FDOT's State New Starts funding for the Jacksonville Transportation Authority's Bay Street corridor project. FDOT staff have had an opportunity to discuss the questions with our transit team. Below are FDOT's summary of the questions and responses.

### **Is the project eligible for funding given that the project is not an extension of the fixed guideway Skyway System?**

FDOT does not consider the project a fixed guideway extension. The funding was granted as a standalone Bus Rapid Transit project along 1.5 miles of Bay Street. FDOT's Work Program Instructions (Part III, Chapter 15, Section 4.a) state:

*"A state New Start Transit Project (NSTP) is a fixed-guideway rail transit system or extension, or bus rapid transit (BRT) system or extension meeting the Federal Transit Administration (FTA) definition of a Capital Investment Grant Program New Starts, Small Starts, or Core Capacity project."*

### **Is the local match sufficient to match the \$13,000,000 in State New Starts funding?**

JTA has provided FDOT an updated funding plan that documents that the JEA will provide \$5,660,000 in services/materials/funding and JTA will fund a minimum of \$7,340,000 toward the project. No other sources are being considered as a match for state funds. Florida statutes allow FDOT to provide 50% of the non-federal share of transit capital improvement projects.

At the April 8, 2021 Board Meeting of the North Florida Transportation Planning Organization (TPO), Board Member LeAnna Cumber, Member of the Jacksonville City Council, asked questions regarding the Ultimate Urban Circulator (U<sup>2</sup>C) Bay Street Innovation Corridor (BSIC) project's inclusion to the North Florida TPO Transportation Improvement Program (TIP) for FY20/21 through FY24/25. Council Member Cumber requested the TPO Board to table the vote for inclusion of the project until next month. The TPO Board voted to approve the TIP without the BSIC and will consider the inclusion of the project at next month's meeting.

This memo outlines the information regarding the BSIC project. This information will address the questions raised at the Board Meeting.

## ***Background***

In 2018, the JTA partnered with community stakeholders to pursue the U.S. Department of Transportation's (USDOT) Better Utilizing Investment to Leverage Development (BUILD) grant. Project partners include the City of Jacksonville, Florida Department of Transportation (FDOT), North Florida TPO, Downtown Investment Authority (DIA), the JEA and the JAX Chamber. Integral to the successful grant award was the establishment of the Bay Street Innovation Corridor Council (Council). The Council consists of project partners as well as the Jacksonville Jaguars and downtown development partners, and meets monthly to drive alignment across all key stakeholders to support the successful deployment of the BSIC project.

## ***Budget***

The BSIC project is the first phase of the U<sup>2</sup>C program. The project is budgeted at \$44 million as included in the grant agreement entered with the Federal Transit Administration (FTA). The total costs and sources of funding are as follows:

The USDOT awarded the \$12.5 million BUILD Grant to the JTA in December 2018. The USDOT Secretary Elaine Chao announced the BUILD grant award on the steps of Jacksonville City Hall in February 2019.

In a March 4, 2020 letter to the JTA (*see attached*), FDOT agreed to provide a State match of \$13 million to support the project. The JTA will match dollar per dollar the state match with local funds, including covering private sector funding if it does not materialize in the procurement process. Other funds to support the BSIC project include in-kind participation from the JEA and the North Florida TPO, who are partners in delivering the project.

#### ***New Starts***

In its March 4, 2020 letter to the JTA (*see attached*), FDOT agreed to fund the state's share of the program through its New Starts program in the State FY21/22. According to the letter, their funding "...will provide the state match of 50 percent of the non-federal share" for the project.

Per Florida Statute 341.051(5)(a), "*The department may fund up to 50 percent of the nonfederal share of the costs, not to exceed the local share, of any eligible public transit capital project or commuter assistance project that is local in scope; except, however, that departmental participation in the final design, right-of-way acquisition, and construction phases of an individual fixed-guideway project which is not approved for federal funding shall not exceed an amount equal to 12.5 percent of the total cost of each phase.*"

#### ***Procurement Status***

The JTA issued a Request for Proposals (RFP) on January 13, 2021 to the two firms the JTA qualified through a Request for Qualifications evaluation process. One of the qualified firms withdrew from the Project citing an inability to meet all of the technical specifications. The remaining firm has confirmed their commitment to submitting a proposal and completing the Project. The JTA has ensured that the specifications in the RFP are not overly restrictive and has encouraged industry awareness, input and competition on this project since 2017 through two industry forums, two requests for information, vendor meetings, speaking engagements, and through advertising the solicitations in state and national publications. The JTA has planned technical discussions ahead of the proposal due date of May 13, 2021. In accordance with state and federal requirements, the JTA will evaluate the proposal based on the criteria in the RFP. It is anticipated that a contract award will be presented to the JTA Board at the June 2021 Board Meeting. It is the JTA's intention to begin this first-of-its-kind Autonomous Vehicle-Design-Build-Operate-Maintain (AV-DBOM) project by this summer

#### ***TPO Meeting***

The April 8, 2021 TPO Board Meeting was to initiate the formal process by FDOT to include the BSIC project into the North Florida's TIP as an amendment and as committed by the FDOT. The BSIC local and federal funds are already included in the State's TIP and North Florida's TIP. This amendment would include the state match in the North Florida's TIP. The state funding is needed for the JTA to utilize the federal grant award funding. As we are in the procurement phase of the BSIC project and moving toward project start later this year, it is imperative that we make available



the full budgeted amount to begin the project and the TPO approves the amended TIP that includes the BSIC project.

## Overview

Here is the last newsletter of the session! Maybe we could have said it went fast, but it didn't. There were a lot of painful bills, some we defeated and some that have passed by our legislature. It was a session unlike any other and not just because of COVID, although that was a big factor. Certainly, COVID changed the dynamics of the session and that was the predominate factor that allowed many controversial pieces of legislation to pass this year. The session was different overall but one tradition that carried over from previous years was the dropping of the hankie to ceremonially close the session.

Most news stories covering the capitol are saying the governor had a great session. All of his legislative priorities were passed and sent, or will be sent, to his desk for signature. Sadly, the same cannot be said for the voters of Key West. They were sure they had defeated the ports pre-emption bill and that defeat would have allowed the voter referendum to stand. Instead the language of the bill they opposed, and had stopped, was amended onto another bill and passed in the crazy last days of the session. Yogi Berra says it best: "It ain't over till it's over." Sorry Key West.

For the MPO world, the mid-block crossing bills that we feared did not pass. They will be back next year. These are HB 1113 and SB 1492. It was close and could have easily gone the other way, they will be back again in some form or fashion. There were other bills that concerned us such as the RPC bill which happily did not reappear in the last days of the session. For the MPO world it was a good year, more money for transportation and nothing passed that hurt us. I know it sounds like this is a pessimist view, but we have to be thankful for the little things. A \$1B increase in funding is actually a big thing, but keep in mind that was the funding level last year.

As for the one thing that the legislature must do, they passed a budget with total funding at \$101.5B. That is a 9% increase over the current year budget and considering how dire the predictions were at the beginning of the session for the state finances, Florida came out really well.

We could talk about various bills, instead let's look at the results of what passed and what did not. The scorecard can tell the story. This newsletter is quite different from the others this session. Out of habit we still use **RED** to show which bills passed (or a companion bill). Bills that did not pass are shown in strikethrough. As for the newsletter, maybe we will see you next year, time and events will tell. If not, it has been fun to be with you on Saturday mornings over a cup of coffee. Happy Trails! 😊

- April 17, 2021 - Motion to reconsider made and considered the same day (Rule 6.4.(4)) All bills are immediately certified (Rule 6.8)
- April 20, 2021 50th day – last day for regularly scheduled committee meetings (Rule 2.9(2))
- April 30, 2021 60th day – last day of Regular Session (Article III, section 3(d), State Constitution)

## Legislation of interest

This is a summary of transportation related bills filed and published on the legislature's website as of May 02, 2021. The bills are listed in numerical order for your convenience.

**HB 35: Legal Notices – (Fine; Co-Introducer: Grieco)** – Comparable bill SB 402 by Rodrigues. Provides for website publication of legal notices; provides criteria for such publication; authorizes fiscally constrained county to use publicly accessible website to publish legally required advertisements & public notices; requires government agency to provide specified notice to residents concerning alternative methods of receiving legal notices. Filed in the House. Referred to Civil Justice and Property Rights Subcommittee; Judiciary Committee. On Committee agenda-- Civil Justice and Property Rights Subcommittee, 02/03/21, 4:30 pm, Webster Hall. Passed Civil Justice and Property Rights Subcommittee, now in Judiciary Committee. Passed Judiciary, Now on House Floor, 1<sup>st</sup> Reading. Passed the House YEAS 85, NAYS 34. Sent to the Senate. **Passed.**

**HB 53: Public Works Projects – (DiCeglie)** – Revises definition of term "public works project"; prohibits state or any political subdivision that contracts for public works project from requiring specified acts by certain persons engaged in such project or prohibiting certain persons from receiving information about public works opportunities.
