Xan Traversa presented the following amendment to the Transportation Improvement Program (TIP) for FY 2024/25 – FY 2028/29.

Mr. Traversa asked for questions. There were no questions at this time.

**Clay Murphy moved to approve the JTA’s request to amend the FY 2024/25 – FY 2028/29 Transportation Improvement Program (TIP); Kristen Burke seconded; motion unanimously carried.**

**► D. DRAFT JOINT CERTIFICATION OF THE METROPOLITAN TRANSPORTATION PLANNING PROCESS**

Clark Letter presented the draft Joint Certification of the Metropolitan Transportation Planning Process.

Mr. Letter asked for questions. There were no questions at this time.

**Solomon Brotman moved to approve the Joint Certification of the Metropolitan Transportation Planning Process; Clay Murphy seconded; motion unanimously carried.**

**E. UPDATE REGARDING THE FY 2025/26 – FY 2029/30 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

Elizabeth De Jesus informed the group the schedule for the TIP process will be accelerated. In past years, we have received two releases of the TIP project data from FDOT. The initial release typically occurred in March, allowing the first draft of the TIP to be distributed in April for review. A second release followed in April, enabling us to distribute a refined draft in May. Our goal has always been to provide an iterative process allowing early and often opportunity for you to review the information.

FDOT has informed the TPO that starting this year only a single annual release of the TIP project data will be provided. We are currently scheduled to receive

this year's TIP data during the second week of April. This change in FDOT's schedule will require adjustments to our internal processes and timeline for sharing the TIP. We understand this may also impact your workflows. We want to assure you that we will work diligently to provide access to the TIP draft as quickly as possible. We plan to distribute a link to the draft before our May 8 meeting.

A formal TIP presentation will be given at the May meeting, and we will seek approval in June.

Ms. De Jesus asked for questions.

- Ju'Coby Pittman asked when the meetings are done, will staff have a final meeting to disseminate the information.

Ms. De Jesus responded we will come back in June for approval. The last meeting is a virtual public meeting, and all are welcome to participate.

- Jeff Sheffield informed the Board the accelerated timeframe is an adjustment by the Federal Government and will remain going forward.

#### **F. BAY STREET INNOVATION CORRIDOR UPDATE**

Greer Johnson Gillis gave a brief update on the Bay Street Innovation Corridor project.

Ms. Gills asked for questions.

- Jimmy Peluso asked if JTA has ridership numbers for the lunch service that operated in the Brooklyn area a few months ago.

Ms. Gillis responded we had ridership of 200 people for the two-month pilot service.

- Jimmy Peluso asked what the speed of the vehicle will be when it is in use.

Ms. Gillis responded the vehicle cannot go higher than 35 mph.

- Jimmy Peluso stated while the vehicle is operation it will go no higher than 35 mph.

Ms. Gillis responded it will go no higher than 25 mph while in operation.

- Jimmy Peluso asked what the daily ridership projections for this service are.

Ms. Gillis responded she will provide that information.

- Jimmy Peluso asked if the vehicles can go off script to avoid an accident, construction, etc.

Ms. Gillis responded the vehicle will know to avoid any accident, construction, etc. An attendant will be in the vehicle and will be able to maneuver around anything in their path.

- Jimmy Peluso asked when you add the cost of construction, operation and maintenance what is the average cost per trip.

Ms. Gillis responded the construction is \$65 million. We do not anticipate going over the \$8 million annually to operate this service. Ms. Gillis will provide the average cost per trip.

- Jimmy Peluso asked what the average cost of a bus trip is.

Ms. Gillis responded we will provide that information for comparison.

#### **G. SAFE ROUTES TO SCHOOLS ASSISTANCE (UPWP)**

Thalia Fuste gave an update on the Safe Routes to School program.

Ms. Fuste asked for questions.

- Mark McManus asked if the schools must work through their school board to participate in this program.

Ms. Fuste responded the schools can come to us directly.

- Ju'Coby Pittman asked if this program is for new or existing schools. Ms. Pittman also wanted to know if staff will be working with the developers of new schools to ensure there is a safe route to school.

Ms. Fuste responded this grant program is for existing schools. We can work with your county and/or city to look at the ordinances to ensure there is safe walking and biking to a school.

- Kristen Burke asked if staff would provide the Board with this information to share within their county.

Ms. Fuste responded she will provide the Board with the information.

- Nancy Sikes-Kline thanked the TPO for their assistance with this program, as this is an extremely laborious process.
- Miriam Hill commented in Nassau County there are many big boulevards and corridor roads where people go over the speed limit. In the early morning hours, school kids are waiting for the bus along a two-lane road with cars flying by. The buses have no room to turn around inside the neighborhoods, so the bus stops are on the main street. The developers get transportation credits if they put a school at the back of a neighborhood and the whole road is paid for. Ms. Hill thinks we should be more vocal of the things we see that don't make sense especially from a safety perspective.

## **H. SMART NORTH FLORIDA UPDATE**

Garreth Rempel of Trainfo gave a brief update on the data flow and integration into Google Maps.

Mr. Rempel asked for questions.

- Kristen Burke commented she lives on a road where there is one way in and one way out with a set of train tracks. Ms. Burke would like to know what Mr. Rempel's recommendations would be for an area like this.

Mr. Rempel responded we have seen many of these issues in deployments across the country. Some communities use direct messaging signals to let drivers know about a delay. This is an issue we certainly address.

- Jeff Sheffield informed the Board this is the best example of what SNF could be when we stood this up. We started with one sensor on a pole and progressed to FDOT Central Office seeing sufficient value to fund 36 sensors to the idea of statewide deployment.

## **I. EXECUTIVE DIRECTOR'S REPORT**

Jeff Sheffield gave the following update.

- The MPOAC will be holding an informational session May 16-17 in Tampa. Please let me know if you are interested.
- Archer First Response will give a demonstration April 24 of a drone with deployment of a defibrillator and Narcan. We have invited our neighboring county's fire and rescue personnel.

- Draft project lists for CMAQ and SU funding will be brought before you in May with adoption in June.

**J. SECRETARY OF TRANSPORTATION'S REPORT**

**K. AUTHORITY REPORTS**

**James Bennett (for Soo Gilvarry) – JAXPORT** – Uncertainty with tariffs. JAXPORT is very diverse so we should not feel the full impact. The power lines project has full funding, and we anticipate having permits within the next month or so. Construction will begin in late June or early July with completion December 31, 2026.

**Miriam Hill – Nassau County Ocean Highway & Port Authority** – Monitoring legislation in Tallahassee for funds to rebuild our customs facility, which also supports Fernandina Beach's airport and marina. We are monitoring two bills that would change Fedstead allocations. Instead of the numbers being appointed by the Florida Ports Council they will be appointed by the Department Secretary. We have a delegate from our Board to monitor and lobby on our behalf.

**Solomon Brotman – Jacksonville Aviation Authority** – Hermes Company began its operations at Cecil Field for their power plants. We will be going into the debt market for \$300,000,000 in long-term bonds to expand Concourse B.

**Mark McManus (for Captain Gregory DeWindt) – U.S. Navy Representative** – NE FL Regional Council is kicking off their military installation resiliency review of NAS JAX, NAS Mayport, Blount Island and Camp Blanding. Drones will be flying off the coast conducting damage assessments as part of a hurricane preparedness exercise during the last week of April and first week of May.

The UPWP includes administrative tasks including developing the UPWP, a number of required work tasks such as the Transportation Improvement Program (TIP), Congestion Management Process (CMP), Long Range Transportation Plan, and other related planning tasks including transit planning most of which is performed by the Jacksonville Transportation Authority.
